# **CALL TO ORDER**

Chair J.R. Gaylor called the meeting to order at 11:25 a.m. (EDT) in the Fort Sackville Rooms of the Beckes Student Union on the Vincennes Campus in Vincennes, Indiana.

# ROLL CALL/ACCEPTANCE OF AGENDA

Pat Konkle called the roll. A quorum was declared with 10 Trustees present. The agenda was approved by consensus of the Board.

# APPROVAL OF MINUTES

Minutes of the April 24, 2013, and June 18, 2013, meetings had been distributed. Trustee John Stachura made a motion to accept the minutes as distributed. Trustee John Hidde seconded the motion, and the motion carried unanimously.

#### **CHAIRMAN'S REMARKS**

Board Chair J.R. Gaylor made the following comments:

- Reported that Student Trustee Greg Harrell's service on the Board would end on June 30 and thanked him for serving.
- Commended Trustee Rick Schach for participating in the Higher Learning Commission's Strategy Forum as part of the VU team that traveled to Chicago in May.
- Commended Trustee Doug Bawel for his research work on the budget.

Board Chair Gaylor also reported that the Board of Trustees met in Executive Session to evaluate President Helton's performance and employment agreement and noted that the Trustees are pleased with his leadership.

#### MOTION #13-17

Trustee Darrel Bobe made a motion to approve President Helton's Addendum to Employment Agreement, as indicated below, which extends his contract to July 31, 2016. Trustee John Stachura seconded the motion, and the motion carried unanimously.

#### ADDENDUM TO EMPLOYMENT AGREEMENT

THIS ADDENDUM TO EMPLOYMENT AGREEMENT is reached and executed this 26<sup>th</sup> day of June, 2013 between the Board of Trustees for the Vincennes University (the Board) and Dr. Richard Helton, Ph.D. (Dr. Helton).

WHEREAS, the Board is employing Dr. Helton as its President pursuant to an Employment Agreement dated June 23, 2010 and an Addendum to Employment Agreement dated August 1, 2012 by which Dr. Helton is employed by the University through July 31, 2015; and

WHEREAS, the Employment Agreement provides the Board will conduct an annual review of Dr. Helton's compensation and performance during the prior year for the expressed purpose of considering an extension of the term of the contract and adjustments in compensation for the following year; and

WHEREAS, the Board has conducted said review of Dr. Helton's job performance and is well pleased with the leadership Dr. Helton has provided the University during his tenure at the University.

NOW, THEREFORE, the Board and Dr. Helton enter into this Addendum by which the Board extends the term of Dr. Helton's Employment Agreement through July 31, 2016. In addition, the Board determines that Dr. Helton's salary shall be increased 2.108 percent, which increases Dr. Helton's annual salary to \$218,000, which increase is to be effective August 1, 2013. The University shall also make annual contributions of \$51,000 to the University's 401(a) plan on Dr. Helton's behalf, which annual contribution shall be prorated each year and paid in 26 equal payments pursuant to the University's payroll policy.

All of the other terms of the Employment Agreement dated June 23, 2010 shall remain in full force and effect.

IN WITNESS WHEREOF, this Addendum is executed this 26<sup>th</sup> day of June, 2013 by John R. Gaylor, Chair of the Board of Trustees for the Vincennes University, and Dr. Helton.

### REPORTS FROM TRUSTEE SUBCOMMITTEES

#### **University Affairs Committee**

<u>Curriculum Items</u> – Committee Acting Chair John Hidde reported that Provost Chuck Johnson presented the attached curriculum items to the University Affairs Committee for its approval. The Committee is recommending that the Board of Trustees approve these items, as they have also been approved by the Curriculum and Academic Affairs Committee, the Faculty Senate, the Provost, and the President. These items include 11 program deactivations, 14 program revisions, and the approval of two academic guidelines and University Core Curriculum (UCC) items. Many of the program revisions result in a decrease in total credit hours.

# MOTION #13-18

Trustee John Hidde made a motion to approve the attached curriculum items, as noted above. Trustee John Stachura seconded the motion, and the motion carried unanimously.

VU Board of Trustees Regular Session June 26, 2013

#### Finance/Revenue Committee

<u>VU Budget</u> – Committee Chair Mike Sievers reported that the committee met on June 18, 2013, and is recommending to the Board of Trustees that it approve a General Operating Budget of \$76,885,729 for FY2014 and \$78,828,819 for FY2015 with the following major assumptions: (1) tuition and fee increase of \$4.60 (2.8 percent) per credit hour for FY2014 and \$5.20 (3.1 percent) per credit hour increase for FY2015; (2) State operating appropriation level of \$38 million for FY2014 and \$39 million for FY 2015; (3) Enrollment decrease of 100 FTE (1.5 percent), based on current application counts and returning student registrations; (4) Total general fund compensation level of \$51.8 million for FY2014 and \$53.2 million for FY2015, resulting from the following: (a) savings from employee attrition, (b) a 2 percent merit wage base increase each year, (c) an increase of 10 percent in health insurance costs each year, and (d) an increase in the PERF (Public Employee Retirement Fund) employer contribution rate from 9.7 percent to 11.2 percent; (6) Operation of new facilities at Jasper Campus (CTIM) and Vincennes Campus (Art Center) open 2013 Fall Semester; and (7) Budget line item of \$1.3 million for facility R&R expenses for both years. In addition, Room and Board Rates will increase 4 percent for 2013-2014 academic year and 3 percent for the 2014-2015 academic year.

#### **MOTION #13-19**

Trustee Mike Sievers made a motion to approve the General Operating Budget of \$76,885,729 for FY 2014 and \$78,828,819 for FY 2015 with the above assumptions. Trustee John Stachura seconded that motion, and the motion carried unanimously.

Board Chair Gaylor thanked the Administration for all of its efforts in submitting a significant amount of detailed information to the Board of Trustees regarding the budget.

<u>Steam Line Replacement</u> – Committee Chair Sievers stated that the Committee reviewed the bids received on the replacement of steam lines on the Vincennes Campus that are currently about 30 years old. Five bids were received, and the Committee is recommending that the bid from PPMI Construction of Evansville be approved in the amount of \$1,565,000.

# MOTION #13-20

Trustee Mike Sievers made a motion that the Board of Trustees accept the bid from PPMI Construction of Evansville in the amount of \$1,565,000. Trustee Jim McCormick seconded the motion, and the motion carried unanimously.

# REPORTS FROM THE ADMINISTRATIVE LEADERSHIP

#### Marketing/Enrollment Report

Kristi Deetz, Senior Director of External Relations, distributed the VU Fall 2013 Recruitment Report and University Enrollment Report. Ms. Deetz reported that 135 more students had attended the June new student registration program; however, due to a smaller returning class, the Vincennes Campus was still down by 181 students when compared to last year's enrollment. System wide enrollment was down by approximately 197. Accepted applications for the Vincennes Campus were up by 13 percent, supported by steady or increasing submissions in five of the eight markets. Housing contracts by incoming students were up 34 percent over last year, and all of the apartments are full.

# **Conflict of Interest Statements**

Vice President Phil Rath reported that five employees completed the Uniform Conflict of Interest Disclosure Statements, and they are included in the Board book. The Board of Trustees is being asked to approve these statements.

#### **MOTION #13-21**

Trustee John Stachura made a motion to accept the Conflict of Interest Statements that are attached to these minutes. Trustee Doug Bawel seconded that motion. The motion carried with one abstention by Chair J.R. Gaylor.

#### PRESIDENT'S COMMENTS

President Helton introduced VU Golf Coach Dennis Chattin and congratulated both he and the VU Golf Team for winning the NJCAA National Championship. In addition, Coach Chattin was named National Coach of the Year. Coach Chattin praised his team for its success in winning the championship.

Board Chair Gaylor also congratulated Coach Chattin and the VU Golf Team.

President Helton thanked the Trustees for the extension to his contract and stated that he appreciates their support. He also thanked Greg Harrell for serving as Student Trustee during the past year and noted his appreciation of Trustee Rick Schach's participation in the Higher Learning Commission's Strategy Forum this past May. In addition, he reported that the Grand Opening of the Red Skelton Museum would take place on Red Skelton's 100<sup>th</sup> birthday, July 18, 2013, and invited all Trustees to participate in the activities.

Missio

Vincennes University, Indiana's first college, is the State's premier transfer institution and leader in innovative career programming. The VU community ensures educational access, delivers proven associate and baccalaureate programs, and offers cultural opportunities and community services in a diverse, student-centered, collegiate environment.

  - **Rationale:** The program deactivations are a result of low enrollment.

- Mining Technology 8500 (ASCT)
  - Rationale: The program deactivation is a result of low enrollment.

**Rationale:** The program revisions reflect course requirement changes, resulting in a decrease in total credit hours from 63 to 60.

**Rationale:** The program revisions reflect course requirement changes, resulting in a decrease in total credit hours from 63 to 60.

Multimedia Communications 2430 (ASCT)

Rationale: The program revisions reflect course requirement changes.

• Emergency Management and Planning 6034 (AS)

**Rationale:** The program revisions reflect course requirement changes, resulting in a decrease in total credit hours from 69-72 to 66.

Physical Therapist Assistant 6400 (ASCT)

Rationale: The program revisions reflect a degree track change from AS Transfer to AS Career/Tech and course requirement changes, resulting in a decrease in total credit hours from 75 to 70.

Rationale: The program revisions reflect course requirement changes.

• Electronic Media – Emerging Media News Concentration 7111 (AS/ASCT)

Rationale: The program revisions reflect course requirement changes.

• Education – Technology Concentration 8340 (AS)

**Rationale:** The program revisions reflect course requirement changes, resulting in a decrease in total credit hours from 74 to 64.
