CALL TO ORDER

Chair John Stachura called the meeting to order at 3:30 p.m. (EST) in the Circle City 16 Room of the Hilton Inn and Suites, 120 West Market Street, Indianapolis.

ROLL CALL/ACCEPTANCE OF AGENDA

Pat Konkle called the roll. A quorum was declared with 12 Trustees present. The agenda was approved by consensus of the Board.

APPROVAL OF MINUTES

Minutes of the December 7, 2016, meetings had been distributed. Trustee Rick Schach made a motion to accept the minutes as distributed, and Trustee Reggie Henderson seconded the motion. A roll call vote was taken, and there were 12 yeas and 0 nays, with the motion passing unanimously.

CHAIRMAN'S REMARKS

Board Chair John Stachura thanked all of the Trustees for attending today's Board Retreat and appreciates everyone's input. He also thanked the Financial Services Area for its work with the State Board of Accounts; Mike Gress for all of his work regarding the AQIP Portfolio; and Kristi Deetz for her presentation earlier in the day.

REPORTS FROM TRUSTEE SUBCOMMITTEES

University Affairs Committee

<u>Curriculum Items</u> – Committee Chair Reggie Henderson asked Provost Laurel Smith to give a report on the curriculum items that have been approved by the Curriculum and Academic Affairs Committee, the Faculty Senate, the Provost, and the President (attached to these minutes). These items include the suspension of two programs, the

addition of one concentration and two certificates, and the revision of seven programs. In addition, one biology course is being added to the University Core Curriculum Course List.

MOTION #17-01

Trustee Scott Brand made a motion to approve these curriculum items, and Trustee Susan Olesik seconded the motion. A roll call vote was taken, and there were 12 years and 0 nays, with the motion passing unanimously.

Alcohol Policy Revision – Committee Chair Reggie Henderson asked President Chuck Johnson to give a report on the proposed revision of the Alcohol Policy. President Johnson is proposing the VU Alcohol Policy be revised (see attached policy) that would submit the request to the President for his/her approval rather than the Board of Trustees, shorten the amount of time the requesting organization would need to submit its request in advance of the event, and add the Presidents' Room, Fort Sackville Rooms, Jefferson Student Union, and the Jasper Center for Technology, Innovation and Manufacturing to the list of VU facilities where alcohol may be served.

MOTION #17-02

Trustee Rick Schach made a motion to approve the proposed VU Alcohol Policy, and Trustee Mike Sievers seconded that motion. A roll call vote was taken, and there were 12 yeas and 0 nays, with the motion passing.

REPORTS FROM THE ADMINISTRATIVE LEADERSHIP

Marketing/Enrollment Report

Kristi Deetz, Senior Director of External Relations, distributed the University Recruitment and Enrollment Report. The report began with an update on the Vincennes Campus recruitment efforts. As of the filing of the report, 3,042 applicants had been accepted for the fall term compared to 3,229 the previous year. A chart focused on application comparisons by academic colleges was also provided.

Jasper applications totaled 177 with 132 being accepted. On the same date in 2016, 133 students had been accepted to VUJ for the fall term.

American Sign Language reported 29 applications while the Aviation Technology Center reported 85 applications for fall 2017. The acceptance rates were 86.2 and 67.1 percent, respectively.

PRESIDENT'S COMMENTS

President Johnson reported that at the Board Retreat earlier in the day, Maggie Stevens of Thomas P. Miller & Associates reported on the VU Strategic Plan Priorities, which are listed below:

- Enhance Enrollment and Recruitment Efforts
- Emphasize Partnerships with Industry, K-12, and Higher Education
- Improve Student Retention and Success
- Cultivate Internal and External Resources
- Identify and Investigate Opportunities to Establish New Programs and Enhance Existing Programs
- Develop and Implement a Communication Strategy that Promotes and reinforces VU's Role and Identity with Indiana and Elsewhere

President Johnson is asking the Board of Trustees to approve these Strategic Plan Priorities and a copy of the Strategic Plan that was distributed to all Trustees.

MOTION #17-03

Trustee Mike Sievers made a motion to approve the above six Strategic Plan Priorities and the VU Strategic Plan (as attached), and Trustee Drew Brown seconded that motion. A roll call vote was taken, and there were 12 yeas and 0 nays, with the motion passing unanimously.

The president also thanked the Trustees for attending the Board Retreat and appreciated the candid comments.

President Johnson also gave a report on the Honorary Doctorate candidates for this year's commencement ceremonies. He would like to recommend that Tim Swarens, VU alum 1981, received an honorary doctorate at the Vincennes Campus Commencement on April 29. Mr. Swarens is the Opinion Editor of the Indianapolis Star. In

addition, President Johnson would like to nominate Mr. David Chu to receive an honorary doctorate at a later time in the year. Mr. Chu and his family have been responsible for seeing that many students from Hong Kong and China attended VU over the past 60 years.

MOTION #17-04

Trustee Reggie Henderson made a motion to approve that both Mr. Tim Swarens and Mr. David Chu receive an honorary doctorate during 2017, and Trustee Susan Olesik seconded that motion. A roll call vote was taken, and there were 12 yeas and 0 nays, with the motion passing unanimously.

PROPOSED CURRICULAR CHANGES AS RECOMMENDED BY CURRICULUM AND ACADEMIC AFFAIRS COMMITTEE

Vision

Vincennes University is a premier learning institution, widely recognized for leadership in innovation and delivery of successful educational experiences. A breadth of program offerings and a commitment to quality service ensure the University's role as an important link in Indiana's economic and cultural vitality. VU is a diverse community whose members all share responsibility for supporting the University mission and are respected for their contributions.

Missi

Vincennes University, Indiana's first college, is the State's premier transfer institution and leader in innovative career programming. The VU community ensures educational access, delivers proven associate and baccalaureate programs, and offers cultural opportunities and community services in a diverse, student-centered, collegiate environment.

The following program additions, revisions and deletions have been recommended by the Curriculum and Academic Affairs Committee and Faculty Senate for approval by the Vincennes University Board of Trustees:

Program Suspension

- Pharmacy Technician 4831 (CPC)
 - **Rationale:** This Certificate of Program Completion is being replaced with a new Certificate of Graduation as the requirements for this program exceed requirements for a C.P.C.
- Construction Technology, Construction Management Concentration 8242 (ASCT)
 Rationale: The concentration suspension is the result of insufficient enrollment.

Concentration Addition

Philosophy - Religious Studies Concentration 2482 (AA)
 Rationale: The concentration will provide the opportunity for students interested in the study of religion to obtain an associate degree. Projected enrollment is 30-50 over a five-year period.

Certificate Additions

- Pharmacy Technology 4835 (CG)
 - **Rationale:** The certificate will allow students to earn a certificate and enter the workforce after one year of coursework. Projected enrollment is 10 in year 1, 15 in year 2, and 20 in years 3-5.
- Law Enforcement Certificate 7504 (CG)
 - Rationale: The certificate will provide Vincennes University students who take dual credit courses the opportunity to earn a certificate. Projected enrollment is 25-30 the first year, and increasing an additional 20 per year over the remaining five-year period.

Program Revisions

- World Languages and Cultures 2200 (AA) (formerly Modern Foreign Languages)
 Rationale: The program revisions reflect the addition of an option of Japanese courses to fulfill the intermediate reading requirements.
- Philosophy 2480 (AA)
 - **Rationale:** The program revision reflects the replacement of HUMN 210 with the new course PHIL 235.
- Emergency Medical Services 6030 (ASCT)
 - Rationale: The program revisions align the program with other allied health programs and more appropriately reflect the United States Department of Transportation's National Education standards for Paramedic.

- Emergency Medical Services/Paramedic 6035 (CG)
 Rationale: The conversion from a CPC to a CG aligns the program with other allied health programs and more appropriately reflects the United States Department of Transportation's National Education standards for Paramedic.
- Nursing, Associate of Science 6250 (AS)
- Nursing, ASN Completion Concentration for Licensed Practical Nurses 6252 (AS)
 Rationale: The revisions in the nursing programs reflect recommended changes based on a review of the National Council Licensure Examination for Registered Nurses (NCLEX-RN) and advice from an outside consultant.
- Fire Science and Safety Technology 7350 (ASCT)

 Rationale: The program revisions reflect the addition of two new optional courses, notation of affiliation with the Florida Department of Education, and up-to-date reference for the governing body of accreditation.
