#### **University Affairs Committee**

<u>Curriculum Items</u> – Committee Chair Reggie Henderson gave an overview of the curriculum items presented by Provost Chuck Johnson at the University Affairs Committee earlier in the day. He reported that the attached curriculum items have been approved by the Curriculum and Academic Affairs Committee, the Faculty Senate, the Provost, and the President, and the committee is recommending approval of these items to the Board of Trustees. These items include the activation of the Mining Technology Program at the Gibson County Center and the addition of two chemistry classes to the UCC course list. In addition, concentrations in the Biological Biomedical Sciences have been condensed and revised into concentrations with flexible tracks.

# REPORTS FROM THE ADMINISTRATIVE LEADERSHIP

# Marketing/Enrollment Report

Kristi Deetz, Senior Director of External Relations, reported on the results of the October 15 census. System-wide headcount enrollment reached 19,203 students. Enrollment figures were then shared for each campus code including growth on the Vincennes Campus, at American Sign Language, in Early College and Project EXCEL, in Business and Industry, and at Gibson and St. Augustine locations.

Ms. Deetz continued with the application status for fall 2015. Vincennes applications were showing an increase of 10.6 percent while accepted applications had increased by 13.2 percent. Jasper applications were ahead by four while the Aviation Technology Center had recorded an additional 21 applications, as compared to the same point in time last year.

Ms. Deetz ended the report with information on the continuing campus visitation programs. To date, over 2,700 students had visited the Vincennes Campus during the fall term.

#### **VU Foundation Board of Directors**

Vincennes University President Dick Helton reported that per the VU Foundation's Bylaws, the VU Board of Trustees needs to approve the nomination of new Directors on the Foundation Board. Vision

Vincennes University is a premier learning institution, widely recognized for leadership in innovation and delivery of successful educational experiences. A breadth of program offerings and a commitment to quality service ensure the University's role as an important link in Indiana's economic and cultural vitality. VU is a diverse community whose members all share responsibility for supporting the University mission and are respected for their contributions.

Mission

Vincennes University, Indiana's first college, is the State's premier transfer institution and leader in innovative career programming. The VU community ensures educational access, delivers proven associate and baccalaureate programs, and offers cultural opportunities and community services in a diverse, student-centered, collegiate environment.

The following program additions, revisions and deletions have been recommended by the Curriculum and Academic Affairs Committee and Faculty Senate for approval by the Vincennes University Board of Trustees:

# Program Activation and Extension to Gibson County

Mining Technology 8500 (ASCT)

Rationale: The MSHA certification miner training component has been moved to the Gibson Center and student feedback as well as the area's increase in mine construction and mine-related employment indicates the need for the program. Enrollment is projected at 20 students over the next five years.

#### **Concentration Addition**

Biological, Biomedical Sciences – Zoology and Marine Biology Concentration 4019 (AS)
 Rationale: The new concentration under Biological, Biomedical Sciences will provide a specialized concentration for students interested in more traditional organism-based areas of the biological sciences. Projected enrollment is 5-10 students for each of the first two years and 10-20 students per year in years three, four, and five.
