# REPORTS FROM THE ADMINISTRATIVE LEADERSHIP

# **Recruitment/Enrollment Report**

Kristi Deetz, Senior Director of External Relations, and Heidi Whitehead, Director of Admissions, distributed the University Enrollment and Recruitment report. Reports showed that while 29 less applications had been received, 158 more students had been accepted. At this point in time, 44 less students were enrolled for 2019 compared to 2018, but the registration process had just begun. The April START VU registration event brought 163 students to campus compared to 133 in 2018. As of April 22, 13 START VU Days remained with 506 reservations.

At the time of report, 3,514 prospective students had visited campus. This reflects a 6% decrease when compared to the same stage in 2018. Two of the four visitor categories showed an increase with individual visits being up 22% (648 students) and Junior Day increasing by 12% (776 students). PreVU Days did decline by 14% (323) but this loss was due to a calendar offset. A reduction in lower conversion activities allowed for more activities with stronger results. Fall 2019 applications at the Jasper Campus have decreased by 14, but 5 more have been accepted. The Aviation Technology Center is showing growth in apps, acceptance, and enrolled with 73 more applications, 38 more accepted, and 10 more enrolled. 22 less students have applied to the American Sign Language resulting in 18 less accepted apps. Distance Education, while being down 59 applications, have accepted 3 more and enrolled 1 more as of the report. System wide totals as of April 15, 2019 reached 1,765 compared to 2,054 in 2018. Campuses showing growth in enrollment are the Jasper Campus (152 vs 149) and the Aviation Technology Center (54 vs 42).

Trustee Reggie Henderson expressed concerns about the enrollment numbers and any adjustments that may need to take place on the finance side. President Johnson responded that we have been proactive in developing and instituting new strategies in recruitment, and recently launched an initiative to help CTE Early College students with housing scholarships. He, too, shares concerns regarding enrollment numbers, but this is not a problem that is unique to strictly VU. The President also stated that the institution has been very diligent in managing resources during this period of declining enrollment numbers. Student Trustee Brianna Jobe stated she was involved in a Nursing Advisory Board Meeting and one of the students in the meeting was from the Chicago area. This particular student spoke highly of VU and was looking for possible ways to build a bridge between VU & more students from the Chicago area.

## PRESIDENT'S COMMENTS

- The President reported that he, along with Mike Gress, Provost Treanor, and Jennifer Holscher (Institutional Research) have worked to map out the Strategic Plan Key Performance Indicators, which were distributed to the Board. The intention is to provide the Board with these updates on an annual basis. Trustee Bobe stated that he has had concerns with the growing popularity of dual credit and if this has not had a somewhat negative effect on enrollment numbers. President Johnson responded that there has probably been some effect on university enrollments, state-wide, as a result of dual credit. However, some positives are that data supports the students who come to a university with more dual credit are succeeding at a significantly higher rate than those students who do not have any dual credit. On time graduation rates are also higher for those students who had dual credit. We need to continue to build bridges for these students that have dual credit, as well as with our CTE centers.
- On March 29<sup>th</sup> at the ATC, VU hosted a state-wide symposium on work-based learning and CTE education, in which we showcased some of our work-based partnerships and our Early College CTE programs.
- Commencement season will begin on May 4<sup>th</sup> on the Vincennes campus, and we currently have 1,864 petitions to graduate from all sites & locations.
- We have promising data on dual credit numbers and seeing interesting patterns with respect to CTE vs non-CTE credits / VU vs non-VU credits.
- The search for VU Foundation Executive Director/Institutional Advancement Senior Director has re-opened and the search committee is reviewing a slate of candidates. The hope is to have someone in place by the time classes begin in the fall. The President thanked Kristi Deetz for her time serving as Interim Director.

- Today is Denim Day, which recognizes sexual violence & offers support for sexual violence victims across the United States.
- VU will once again have nine faculty teaching in Funing, China this summer.
- VP Phil Rath was recognized by Governor Holcomb on April 10<sup>th</sup> with a Sagamore of the Wabash award.
- VU alum Jakob Blass was recently named by the U.S. Coast Guard as its Enlisted Person of the Year.
- Former VU Swimming & Diving Coach Harry Wickens, and former VU Track & Field All-American Natalia Bartnovskaya Price were recently inducted into the NJCAA Hall of Fame.

# REGONITION OF THE GOLF TEAM & MEN'S BASKETBALL TEAM

President Johnson invited Athletic Director Harry Meeks to introduce the coaches & student-athletes from the golf team and men's basketball team, both of which won national championships over the past 12 months. Golf Coach, Dennis Chattin, introduced the members of the golf team, and Men's Basketball Coach, Todd Franklin, introduced the members of the basketball team, as well his assistant coaches, Brian Davis and Willie Wiley, who is also a former VU basketball player.
